Are you a creative MSME based in Jordan with an idea ready to launch or expand?

CREACT4MED, an EU-funded project which aims to strengthen businesses within the cultural and creative industries, offers **direct funding to launch or expand cultural and creative businesses in Jordan** that have a high potential to generate innovation and jobs, in particular for young people and women.

The **overall objective** of the CREACT4MED funding scheme is to support selected MSMEs active in the cultural and creative industries to overcome barriers to business development and market access, harness innovation, technology and creativity to improve business operations, and to increase their capacity to create jobs for young people and women.

The specific objectives of this call are:

- 1. To facilitate the development, launch, promotion and improved access to local and international markets of innovative business ideas in the cultural and creative industries through the provision of funding and technical assistance services.
- 2. To foster social inclusion and create job opportunities, particularly for women and young people, in the provision or preservation of cultural and creative goods, products or services.
- 3. Create a hub to support young people and women involved in CCI entrepreneurship within the target countries, bringing together incubation, support, education, finance and other actors.

#### What's in it for entrepreneurs

Successful applicants to this call will benefit from:

- A sub-grant of up to EUR 15,000 in order to implement their project proposal
- Technical Support Services implemented by <u>CREACT4MED incubators</u>
- Networking opportunities offered through the Mediterranean CCI HUB
- Visibility through the project's website, events and other initiatives



## Who can apply?

This call is open to MSMEs based in Jordan active in the cultural and creative industries (CC). The following conditions must be met to be eligible for funding:

- Be a legal entity registered in the commercial registry of Jordan after 2012. Unregistered entities are welcome to apply to this call, but will be required to commit to registering before any funds can be transferred.
- Be a micro, small or medium-sized enterprise according to Jordan's legal definition: have fewer than 200 employees.
- Be active in the cultural and creative industries.
- Be registered to the CREACT4MED Community Platform.
- Be directly responsible for the preparation and management of the action, not acting as an intermediary.

## Indicative eligible activities

Proposed activities should have a maximum duration of 8 months and fall into one or more of the following priorities:

>- Development or improvement of staff ICT skills and competences

## **Technical support services**

Successful applicants will benefit from incubation services offered by TTi:

- **Objective:** The incubation program aims at assisting 10 women entrepreneurs working on the cultural and creative industries in validating their business model, prototypes, products and MVPs through a series of support services including mentoring, training, business linkages and access to finance with the final goal to grow their start-ups, complete some sales cycles and increase revenue.
- Indicative start date: October 2022
- Duration: 3 months

## **Application process**

Application to this call for proposals comprises the submission of:

- (1) <u>Application form and Proposal outline</u>, including 1) a signed declaration of honor on exclusion criteria and 2) selection criteria and a de-minimis self-declaration
- (1) Mandatory attachments:
  - a. Registration document **or** letter of commitment to register the company within the 30 days following the award of the sub-grant
- (2) Optional attachments:
  - a. Business Model Canvas or Pitch Deck
  - b. Certificate of participation to a training/capacity building program relevant to the implementation of the proposal
  - c. Collaboration agreement(s) with other stakeholders

Applications may be submitted in English or French, but <u>the ability to communicate in English</u> <u>is required</u> in order to implement the funded projects.
